# Call for paper

## Call for paper

The annual conference of the French Society of Sports Psychology will take place from May 27th to 29th 2020 in Brest, France. SFPS invites full length and work-in-progress papers. You can submit an abstract of your work for oral or poster communication. Oral papers may be submitted in the form of symposia consisting of 4 or 5 presentations on the same theme. Papers can cover all areas of sport and exercise psychology. All research methodologies are accepted, as long as they are clearly stated.

Posters on intervention practices in sport and exercise psychology may be submitted. Researchers, clinicians and students are invited to submit current papers on PST, sport performance enhancement, improvement of sporting performance, management of psychological difficulties of athletes or promotion of health through physical activities.

The SFPS 2020 annual conference in Brest will promote innovative concepts, theoretical models or methodologies that have not yet been explored and that have promising applications. Innovation will also come from breaking down the barriers between disciplines through the proposed communications. Multidisciplinary and interdisciplinary work (psychology and other sports sciences) will be particularly welcome.



## **Submission format**

may submit abstracts Authors in English, following French or a standard "Introduction, Methodology, Results, Discussion" plan.

- A list of maximum 5 key-words is to be provided following the abstract. The title of the communication must be sufficiently informative.

#### **Special cases:**

for which results are not available at the time of submission may "Results" the section with "Expected Results" and the "Discussion" section with "Possible Implications".

Symposia abstracts are to be submitted in a single document comprising: a 250-word abstract, the list of speakers and 5 keywords for the entire symposium, as well as a standard abstract for each of the presentations with the title, list of authors and 5 keywords.

Summaries of posted communications on intervention practices will follow a plan entitled "Introduction, Target Population, Methodology Implementation, and Assessment and Perspectives".

### Acceptance

After expertise by the Scientific Committee, a notification of acceptance will be sent within 21 days. Notifications of acceptance will therefore be made "as you go along": the first authors to submit an abstract will also be the first to be informed. Changes may be requested by the Scientific Committee. Authors will then have 15 days to submit the final version of their abstract. Abstracts will be printed according to the submitted version. It is therefore important to take the greatest care in the drafting and formal quality of these abstracts.

## Young Researcher Award

Master's or PhD students, as well as young doctors who defended their thesis less than 1 year ago, are invited to compete for the young researcher award. To compete, candidates must be the first author of their paper. Winners (first place) from previous years cannot compete for the 2020 Young Researcher Award. Only one paper per author may be submitted for the "Young Researcher" award.

The evaluation of the papers will be in two parts: the quality of the abstract submitted and the quality of the presentation of the paper. Authors wishing to compete for the award must therefore be present and available when their communication is scheduled. The Scientific Committee will evaluate the papers. The main evaluation criteria are the originality of the communication, the clarity of the presentation, and the innovative and applied nature of the work presented. A prize will be awarded for each type of communication (oral and poster).



## Format of poster communications

#### **Poster communications**

Two poster sessions will be offered. Posters should follow the A0 format (84.1 cm x 118.9 cm), in portrait orientation.

The text should be clear, concise and legible at a distance of 1.5 m to 2 m.

Illustrations are welcome.

Posters should be installed at the beginning of the day on the locations whose numbers will appear in the program.

Two people from the organization will be available to inform and assist you.

The posters will be displayed all day Thursday or Friday (with a 2 mn presentation), then removed the same day by the participants.

#### **Oral communications**

The duration of each presentation is set at 15 minutes, including 12 minutes of presentation and 3 minutes of discussion.

Papers will be grouped by theme. A video projector will be made available to the speakers.

Speakers will have to upload their presentation on the computer before the start of the session or during the previous break.

## Oral communications in a thematic symposium

The duration of the symposium is set at one hour, which may include 4 or 5 papers.

Papers should be of a balanced length and an exchange time should be considered (e.g. four papers of 12 minutes, 12 minutes of discussion).

The symposium organizer is responsible for collecting all the abstracts of the symposium participants.
